# Year End Report – On the Road to Recovery

## RECENT PROGRAM FUNDING

This year has seen many difficulties for arts organizations that carried on throughout the Covid shutdowns. Minstrel has been pleased to assist groups reaching out either virtually or in person to young people in Toronto. In December, we were thrilled to be able to support some groups who've made it into, what we hope, will be a happier 2022. Among the grants are \$10,000 for the **Hammer Band**. Moshe Hammer's group managed to keep the music playing through virtual meetings. Now, the band returns with professional music instruction for kids from inner city neighborhoods and new immigrant communities. Minstrel will sponsor 50 youngsters from two downtown schools for a year of instruction, fun, and fellowship.

Impact studies done for the Band indicate that student participants gained in social skills, mathematics, ability to focus, and improved self-esteem. Hammer Band has spread from two schools in North York to schools across the GTA. Minstrel is proud to be a continuing funding source for this terrific program.

Along with Hammer Band, Minstrel has renewed it's funding for the **Pia Bouman School of Ballet and Creative Movement**. Bouman also continued online programs during Covid and students are overjoyed that in class learning is back. Minstrel is providing \$5000 for subsidized lessons. Three advanced level students, Alaia, Ningdi, and Maria, and two younger students Katie and Sh. whose parents/guardians are feeling the on-going Covid-19 stress will be given full scholarships for their studies.

We are once again working with the **University Settlement** music program which reaches dozens of inner-city youngsters. Their Music and Arts School has been granted \$35,000 for subsidized lessons. Currently, Minstrel funds support one-on-one lessons for approximately 100 young people in the downtown core.

**Culture Shock Canada Charity** approached Minstrel with a proposal for an online dance program for youth. Through structured urban dance-based education and enrichment programs for youth, they address issues of social isolation & self-esteem, and build relational, teamwork, and leadership skills. The Summer Arts Camp at **St. James Town Community Arts** provided in person music and arts for 25 youth for two weeks. spring 2020 enabled Culture Shock to increase their online learning for 2021. We were able to provide a \$2000 grant. The Culture Shock website shows just how talented these young people are.

We are pleased to report the return of the **Canadian Children's Opera Company** and their community outreach program. Minstrel is a supporter of this group and their music education program that provides an introduction to opera for children who otherwise could never have access to this experience. A Minstrel grant of \$10,000 has enabled the CCOC to beef up their on line programs and continue their musical education programs in the public schools. Their efforts also support more than 90 students who are continuing some form of music training.

The Minstrel Foundation is funding the **St. James Town Children's Choir** from Sept. 2021 to June 2022 with a grant of \$5,450 plus rental costs. The program will be operating virtually from September to December at the very least and most likely until March break. The program cost includes online rehearsals, virtual choir videos and accompaniments.

We are pleased to be able to continue to support these worthwhile endeavors and we thank you, our donors, for making these ongoing programs possible.

# Slaight Family Foundation Donates \$100,000

In 2003, Aida Slaight made the first of her 5 year pledges to the Minstrel Foundation. Since her passing in 2020, the Slaight Family has continued with its generous support. We are pleased to announce that this year the Slaight Family Foundation made a \$100,000 pledge to the Minstrel Foundation to be advanced in equal installments of \$20,000 over the next five years.

The **National Music Camp** also managed a one week summer program including master classes and performance training.

This year, Minstrel funded 13 kids from Dixon Hall Music School, 5 from University Settlement, and 7 from Matthew Ferguson Scholarship Fund. Once again, youngsters reported a season where they increased their musical training and also enjoyed games and sports. Cost for 25 campers to attend was \$24,000.

Hammer Band also had their Summer Jam program, a virtual cornucopia that included games, online concerts, practice challenges, and all-round fun. The on-line event reached 275 children across the city and lasted for 12 weeks, Costs, primarily for teachers and administration came to \$39,000 and Minstrel was pleased to participate with the \$5000 grant requested.

In addition, Minstrel also provided \$2,100 to allow 5 youngsters to attend the **Royal Conservatory** summer virtual camp and another 5 youngsters to take their RCM exams. Congratulations to them all.

We recently received a letter from **Hayley Naunton**, a former student at the Dixon Hall Music School and a Minstrel Scholarship recipient. Hayley's dream was to become a music therapist. In December 2020, she graduated with a degree from Wilfrid Laurier University and is currently employed as a music therapist working with people with brain injuries. She has also reconnected with the Dixon Hall Music School where she began her own studies and plans to assist them in setting up an adaptive music program for children with disabilities. The brand new **Ivy Rose Scholarship** made its debut this year. The award is named for a young woman who was diagnosed with Ewing's Sarcoma at age 4. Despite an amputation to save her life, Ivy Rose danced and danced until the disease took her life but her spirit continues through other young dancers.

Pia Bouman chose **Lily Chavez-Muir**, aged 12, for this award. Lily is not only a talented dancer, with years of study already but is a support and inspiration to her peers and a model for younger dancers. This year, she plans to dance as Clara in the Nutcracker as well as a doll in Columbine. Congratulations to Lily.



The **Tammy Hermant Award** this year goes to **Mariammal Sridharan**, aged 14, of Toronto. Mariammal is a member of the St. James Town Community Arts program and is a student in vocal training. She is also a member of the Canadian Children's Opera Company and recently participated in a summer opera camp. Vivid, a pianist, was known to Ms. Hardy who recognized her talents early. Now, Vivid is a fourth year student in performance at the University of Toronto in the very competitive Bachelor of Music program. ## Minstrel Annual Fundraising Campaign Again Goes Virtual

For the second year, the Minstrel Foundation was not able to hold its annual fundraising Gala because of Covid restrictions. In its place we are again conducting an online video campaign which began in December and will continue into the early part of the new year. We have relied on our annual fundraising gala for more than 50% of our annual funding requirements. Last year, thanks to our major sponsors and many donors, we were able to achieve our goal.
